Footnotes

SWIFT MELVA steadily angled in as she vied for the early lead, was steadied slightly leaving the half mile marker, had the rail on the turn, swung out three wide leaving the bend, took over inside the final furlong and was driven clear. ALIBI LADY also slowly angled in as she contested the pace from outside, was two wide through the bend, battled in the lane but was no match for SWIFT MELVA late. SPECIAL CHANCE came in gradually, as well, as she dueled for the early lead between horses, gained the rail into the turn, began to tire inside the final furlong and was angled out with a sixteenth left. CHASING PARIS without early speed, began to progress along the rail on the turn and passed tired ones from inside through the stretch. MSROCKETLEGS was jostled hard near the half mile marker, checked behind SWIFT MELVA shortly after that, came off the inside some, was just off the rail entering the lane and had no late bid. ALASKAN RHYTHM altered in trying to stay clear of SWIFT MELVA shortly after the start, bumped CHOCOLATE LADY, was just off the inside taking the turn, moved to the rail for a clear path inside the eighth pole and lacked a significant response. SIMPLY MAUVELOUS altered out to avoid the jostling rivals just in front of her at the half mile marker, lost ground four wide on the turn and failed to have a stretch bid. RAJULIE gradually came in trying to stay clear of SWIFT MELVA on the backstretch, jostled hard with MSROCKETLEGS near the half mile pole, was checked solidly, three wide taking the turn and faded for the drive. GUITAR LADY fractious behind the gate, bumped twice with CHOCOLATE LADY early, showed no speed, was widest taking the turn and empty in the lane. CHOCOLATE LADY bumped several times at and shortly after the break, was soon far back, saved ground and proved unresponsive. There was a stewards' inquiry into the MSROCKETLEGS' and RAJULIE'S loss of action near the half mile. After their review, SWIFT MELVA was disqualified and placed eighth for coming in without being clear of her rivals.
