### Footnotes

BATH HOUSE BET was rated off the rail, commenced her bid three wide on the second turn, drifted out into the lane and gradually drifted out the final furlong but caught PHONE JOAN nearing the wire and began to draw clear. PHONE JOAN broke in stride, moved to the rail into the first turn, was soon engaged by REMEMBERTHECOWGIRL, drew clear when asked leaving the second turn, came two wide into the lane, drifted out some midstretch, was soon corrected but did not have enough left. WILDARADA settled midpack, took the second turn four wide, was fanned out behind HONORABLE KING into the stretch and found best stride too late between rivals. REMEMBERTHECOWGIRL was steadied briefly when PHONE JOAN crossed her path going to the turn, moved up outside that one to vie for the lead, could not keep up leaving the second turn, was altered in some leaving the furlong marker, continued to lug in, taken in hand at that point and was under wraps the rest of the way. FIERY SALSA settled, gradually improved position inside, was swung out three wide into the stretch, altered in going to the eighth pole to keep a clear path, was forced to check on REMEMBERTHECOWGIRL'S heels nearing the final sixteenth and altered outside that one after that. MANDA'S APPLE two to three wide, was never a factor. DENOUNCER'S GIRL quickly faded outside into the first turn, was taken inside on the second turn and came up empty for the stretch run. After a stewards' inquiry into the stretch run, REMEMBERTHECOWGIRL was disqualified for interference to FIERY SALSA nearing the final sixteenth and placed fifth.
