Footnotes

PALACHEE bumped with COOKIE CZAR at the start, was sent to dispute the pace between horses, did not stay with GATE PRANCER while just off the inside on the bend, drifted out to path five into the lane, gained the advantage nearing the furlong marker, drew clear nearing the sixteenth marker, was all out, lugged in some late but held off PHAETON'S JUNIOR. The latter showed first, dueled for the lead from inside, also did not keep up with GATE PRANCER through the bend, was checked as he swiped the rail into the lane, was put to a drive upper stretch and gradually closed the gap the last sixteenth. GATE PRANCER hustled along to share the lead from outside, moved clear on the bend, stayed just off the inside, floated out some for the stretch run, slowly wore down and tried to drift out with a sixteenth left. CALHOUN COUNTY a step slow at the break, progressed from outside, four wide on the turn, angled in to be just off the inside leaving the bend, advanced to the eighth pole then finished evenly. COOKIE CZAR bumped with PALACHEE at the start, stumbled, was without speed from between horses, three wide through the turn, angled outside CALHOUN COUNTY just after entering the last furlong and made up some ground deep stretch. HAYNES chased from inside, could not keep up along the rail through the bend and lacked a significant stretch response. BROWN PIRATE in the second flight between horses, was three wide on the turn, fanned out to path five for the stretch run and began to tire. ELECTRIC STRIDE void of speed toward the outside, advanced four wide on the turn, swung widest for the drive and made up minor ground late. LOR RENZIO also a step slow at the start, was void of speed though urged along, steadied briefly and altered out to avoid EXMAT at the quarter pole, floated to path five entering the lane and lugged in midstretch. EXMAT gradually backed up from just off the inside, moved to the rail nearing the quarter pole, was empty and steadily gave way.
