SEYRULE was soon clear and had the inside, showed the way in hand, lengthened command when let out on the second bend, responded to nearly all hand urging in the lane and was much the best. N EIGHTEEN steadied when his path was taken early in the first bend, gradually progressed from outside, took the rail into the second turn, swung out three wide nearing the final furlong and caught EAGLE EYE JUSTICE for second with a sixteenth to go. EAGLE EYE JUSTICE forwardly placed outside, moved to the inside on the second turn, was put to a drive at that point, steadily advanced, took over second upper stretch but did not have enough left the final sixteenth. ANGEL FIRST CLASS pressed the pacesetter from just outside, could not stay with SEYRULE on the second turn and began to tire the last furlong. JUNIOR'S BOOST TOO soon trailed, saved ground, passed tired ones upper stretch then leveled off. PROPANE was checked behind traffic nearing the first turn, swung out early in that bend, showed no speed, was widest into the lane and lacked a stretch bid. MR. POSH boxed in early, angled out three wide on the second turn and steadily gave way. WHAMMY'S BOY never far off the inside, faded before finishing a half mile.
