### Footnotes

DOMAIN'S RAP stalked the early speed first along the rail then just off the inside, was steadied briefly when his path narrowed into the turn, split rivals two wide shortly after passing the three-eighths pole, quickly moved clear, responded to mild urging upper stretch, lengthened command the continued to open up while ridden out the last furlong. SLEWZOOM advanced to contention from inside on the backstretch, improved position just off the inside on the second turn, took over the place upper stretch and shook free for that position late. OFFICER MCNEAL moved with SLEWZOOM from just outside throughout, began to yield deep stretch but was easily best of the rest. HOTROD STICK gradually advanced widest to midstretch then leveled off. MAMONIUM MOON displayed early speed from path three, was no match for DOMAIN'S RAP leaving the second bend and flattened out through the lane. THE ALCOVA KID a step slow at the break, was soon far back, saved ground, swung out for a clear path leaving the second turn but proved empty. BROTHER DAN contested the pace inside to the second turn then quit.
