TRE BOSS vied for the lead under a stern drive, moved clear inside the furlong marker, gradually drifted out but held sway. HEZA DARLIN had no mishap, found best stride too late but was clearly best of the rest. SPECIALMANONAMMISSION bumped at the start, dueled for the lead briefly then gradually yielded. WRANGLIN EASY without mishap, ran evenly. KINGS STREAKING ROSE pressed and failed to have the needed late kick. HES REGAL stumbled at the break, was angled in inside the last eighth and had no rally. GC SMOKY JOE hesitated at the start and failed to menace. MDT STREETFIGHTER was bumped solidly shortly after the start and gradually faded. LOUISIANA SONNY BOY broke inward, bumped first with SPECIALMANONAMMISSION then MDT STREETFIGHTER, was erratic upper stretch and showed little.
