Footnotes

BARRY K rated from inside, swung out to path four entering the lane, altered out some for a clear path upper stretch, gradually angled out for room as he rallied inside the last furlong, fought on the front end inside the final sixteenth and edged ahead nearing the wire. Z APPEAL settled just off the inside, altered to the rail for room upper stretch, made a strong move the last eighth, battled on even terms with BARRY K in the waning yards but was outfinished in a game effort. SORROWFUL JONES disputed the pace from inside, floated out a bit entering the stretch and gradually drifted out under left-handed pressure the last furlong. DOODLE DANDY vied for the lead outside from the beginning, three and four wide taking the bend, was slowly forced out inside the final eighth, slowly yielded, was cut off nearing the wire and checked. TIME ADOSIOUS dueled for the lead between horses, was crowded briefly by SORROWFUL JONES upper stretch, began to weaken nearing the eighth pole, was steadied when his path was taken inside that marker and continued a slow retreat. PERFECT TRIP void of speed three wide, swung out widest for the drive and had no late bid. BOWLING soon trailed from outside, angled in to be just off the rail on the turn and was empty for the drive. There was a stewards' inquiry into DOODLE DANDY'S loss of action deep stretch. After their review, SORROWFUL JONES was disqualified for coming out, impeding DOODLE DANDY deep stretch and placed fourth.
