CARLA'S BRAZEN shared the lead in hand inside, responded to urging leaving the turn, drew off and was kept to task. NURSE KATHY, allowed to settle, fanned out six wide into the stretch, drifted out some in upper stretch, lugged back in late making her bid and caught TELL DR. ABOUT IT near the wire for the place. TELL DR. ABOUT IT, blocked behind the leaders to the quarter pole, got through four wide entering the turn, rallied to gain the place at the sixteenth pole but was outfinished. CRYSTAL BLADE shared the lead between horses, was no match for CARLA'S BRAZEN in the drive and weakened the last sixteenth. HOPE'M LEGAL pressed the pace four wide to the top of the stretch, failed to keep up and also closed evenly. DINNER BY CANDLITE, broke awkwardly, shared the lead three wide to the top of the stretch and began to tire.
