POWER CHIPPED pressed the pacesetter from outside, took over from path three on the turn, moved clear into the stretch and held sway under steady urging. GOTCHA CART bumped at the start, was forced in soon after the break, jostled with ROYALTY AT LAST briefly, advanced from outside, was four wide on the bend, angled in some for the stretch run then gradually closed the gap on POWER CHIPPED as he drew away from the rest the final eighth. CONTE DO IT prominent between horses, made his bid three wide on the turn, was just outside POWER CHIPPED into the lane, took over third then could only maintain his position under a stern drive late. SUITED DEUCES bumped by ROYALTY AT LAST a time or two shortly after the start, gained a striking position three wide on the turn, fanned out further for the drive, progressed to midstretch then leveled off. PULPWOOD LAKE forwardly placed between horses, was two and three wide taking the bend, altered outside GOTCHA CART midstretch for a clear path but had no late bid. ROYALTY AT LAST broke outward, bumped GOTCHA CART, jostled between that one and SUITED DEUCES a few strides later, was checked, soon well back, just off the rail into the turn, swung five wide into the lane, drifted out some midstretch and gradually improved position. DEVIL'S BEAU was altered in to stay clear of PULPWOOD LAKE shortly after the start, showed no speed from outside, four to six wide through the bend and failed to rally. MIDRANGE displayed early speed just off the inside, was overtaken on the turn then flattened out along the rail through the stretch. LAVA ON THE RUN in midpack from inside, fanned outside MIDRANGE entering the lane, had little left and finished on even terms for last with that one.
