LAWYER RON bumped with MORE THAN REGAL at the break, rated off the pace from path four, squeezed through between rivals early in the second turn, angled in three wide leaving that bend, gained the advantage in the upper stretch and edged ahead in the late going under a left whip. SMOKEYJONESUTTON settled between rivals, commenced his bid just off the rail into the second turn, weaved through traffic to progress, gained the inside entering the lane, battled for the lead but did not have enough left in a game effort. LEWIS MICHAEL pressed the early pace, angled out three wide nearing the second turn, took over the lead, was challenged from both sides into the stretch, slowly wore down but was easily best of the rest. CIELO GOLD advanced between horses, four wide with a quarter mile left, lacked the needed stretch bid and lugged in late. LIKE AN EAGLE, unhurried early from outside, bid five wide on the second turn, progressed to midstretch then leveled off. CASINO EVIL, rated between rivals early, gained a striking position three wide on the second turn, weakened in the lane and was forced to alter course twice to avoid CIELO GOLD inside the final furlong. MORE THAN REGAL was pinched at the start and shuffled back, trailed from inside, blocked and checked on the second turn, squeezed through two wide leaving that bend, floated out some into the stretch and improved his position. GENERAL DARBY set the early pace inside, gave way on the second turn, checked in tight quarters into the lane then continued to fade. FOLLOW THE STORM disputed the pace just outside GENERAL DARBY, had a brief lead near the second turn but faded leaving that bend, drifted out into the stretch and had little left. STARSPANGLED GATOR displayed early speed from outside but came up empty on the second turn.
