Footnotes

GIVING POINTS settled, picked up his pace on the backstretch, weaved through tight quarters between rivals to advance near the half mile marker, took over two wide on the second turn then steadily opened up in the lane while under a drive to the waning yards. DANDYMAN broke very awkwardly and his rider lost his irons, progressed from outside after his jockey regained his footing nearing the first bend, threatened three wide on the second turn, was no match for GIVING POINTS in the lane, fought for second and edged ahead for the place late. HIGHFLYINGBLESSING gradually advanced from inside on the backstretch, angled out through the second turn, altered outside MABEE STORMY upper stretch, drifted out further going to the furlong marker, held a straight path the last eighth, was all out and caught POLAR EXPEDITION for third. POLAR EXPEDITION moved clear just off the inside on the backstretch, had the rail when he was challenged entering the second turn, also could not stay with GIVING POINTS, fought for second through the stretch but did not have enough left. MABEE STORMY in contention just off the rail, floated out to path five for the stretch run and slowly yielded. COURT COMPOSER soon trailed from inside, came off the rail some for the drive and lacked a significant response. BLACKHAWK RED displayed early speed from inside but gave way on the second turn. KITTEN'S RULE steadily faded from between rivals, was widest on the second turn and continued to give way through the lane.
