**Footnotes**

WHEELS OF JUSTICE had speed inside then stalked a bit off the rail, bid alongside a rival leaving the second turn, took the lead, kicked clear in the stretch and held under urging. WARREN'S RAIL BIRD broke a bit slowly, chased outside a rival then inside, moved up along the rail on the second turn, swung out into the stretch and finished well. BROTHER ERNIE stalked outside a rival, took the lead alongside a foe and kicked clear on the backstretch, set the pace inside, dueled along the rail leaving the second turn and into the stretch and weakened some but clearly bested the others. RED MOUNTAIN a bit slow to begin, settled just off the rail then inside, came out into the stretch and was not a threat. VALEN drifted out into the first turn, chased off the rail to the stretch and weakened. PRAISE FOR DUBAI stalked inside then a bit off the rail, came out into the stretch and also weakened. NITRO POWER fanned wide into and on the first turn, settled off the rail and lacked a response in the stretch. OUR CLASSIC TRIP had speed outside then alongside a rival, inched away and angled in, set the pace inside, dueled on the backstretch, dropped back into the second turn and gave way.
