Footnotes

BEV'S EX dueled inside, steadied in tight into the turn, re-bid along the rail leaving the turn, gained a slim advantage in the stretch and held on gamely under urging. PASEO DE RAMON had good early speed and dueled three deep, inched away briefly a quarter mile out, battled outside into the stretch then alongside the winner through the drive and went willingly to the wire. DIRTY DEED stalked off the rail, came into the stretch three wide and finished with interest three deep on the line. MINISTER MACHINE chased between horses then outside a rival on the turn and lacked the needed rally. FOLLOW THE ARROW between foes early, chased just off the rail then inside on the turn and through the stretch and could not summon the necessary response. EPIC RULE dueled between horses stalked outside the winner on the turn and weakened in the stretch. LE' HEAT bobbled then was squeezed back at the start, saved ground chasing the pace throughout and was not a threat. LOVE TO BARRETT sent along early, chased outside or off the rail, angled in alongside a rival on the turn and did not rally.
