COLUDA sped to the lead into the first turn, set a pressured pace on the inside around the turns and into the stretch, battled back on the inside at the top of the lane, drifted out a bit late and held on gamely for the score. ST PATRICKS APPEAL angled outside the winner in the run into the first turn, pressed the pace on the outside to the stretch, battled between horses through the final furlong, lost a tough decision but held the place on the wire. POWER SERIES was unhurried in the early going, raced three wide around the second turn, down the backstretch and into the stretch, rallied three deep in the final furlong and was edged for the place. CANARD stalked the pace outside a rival around the first turn and between horses around the second turn, could not keep pace at the quarter pole and weakened through the lane. DEPTH stalked inside a rival around the first turn and on the inside down the backstretch, began to weaken entering the third turn and fell back in the final furlong. KUMITE was outrun in the early going, chased a bit off the rail past the stands, angled outside down the backstretch and did not offer a rally.
