Footnotes

INTOTHEWILD prominently placed while three wide early, moved up into second turn, caught four wide into the stretch and bumped with inside rival, reached the front passing eighth marker, edged away and safely held under urging. WOLGAN VALLEY settled off the leaders, chased three wide then four wide around final bend, remained outside and gamely outfinished inside rival for the place. THRICE THE VICE bumped at the start, unhurried from the inside, chased along the rail, taken off the fence, came three wide into the stretch, battled between horses and was out gamed for second. PURE GREEN lagged well back from the inside, remained along the rail, steered out exiting the final bend, came out further and closed strongly from the far outside. SMOKENOMORE angled over early, chased the pace from along the rail, came out some in the drive and finished well from between horses. RAYMANJJOHNSONJR bumped at the start, stalked from between horses early then inside the winner in middle stages and lacked needed late punch. SOGNATORE (FR) stalked pace from off the rail, moved up three wide, loomed leaving backstretch, between rivals and bumped with winner entering the lane then weakened. SAXMAN crossed over and gained stalking position, tracked leader while two wide, secured the rail on the second turn, loomed inside leader but weakened in the drive. RED ON SUNDAY broke inward and bumped foe but quickly recovered and sped to the front, set uncontested pace into

backstretch, came two wide into the lane, lost command and weakened. HITTERS LAST OUT reserved early while taken off the rail, chased well off the fence then five wide into the stretch and was outrun.
