### Footnotes

SUPER CANDY settled in the early going, saved ground around the first turn, angled off the rail on the backstretch the second time around, rallied outside the leader leaving the sixteenth marker and was up in time. JERSEY JOE sped to the early lead, opened up a clear advantage into the third turn, remained clear in mid-stretch and was worn down inside the sixteenth marker. SILVERADO CANYON chased off the rail into the second turn, was asked for run entering the backstretch the second time around, could not mount the necessary rally but was a clear third at the wire. LEGAL VICTORY pulled his way into the first turn, angled to the outside around the turn, chased off the rail and was no threat in the lane. AVEC GLASS stumbled after the start, stalked the pace outside a rival around the second turn, began to weaken on the third turn and fell back through the lane. UNUSUAL MANEUVER stalked the pace on the inside around the clubhouse turn, began to weaken on the backstretch the second time around, lost contact and was eased through the final furlong.
