Footnotes

AQUA FEVER forced the early issue outside foe then grabbed lead midway on backstretch, edged away, resisted inside into the lane, drifted out under left hand urging nearing wire, made contact with outside rival and just lasted from between horses. DIVINE CHILD stalked along the rail early, saved ground to second turn, came out some, steered back inside passing sixteenth marker, surged along the rail and just missed. TWICE THE APPEAL gained stalking position from off the rail, continued three wide, advanced, loomed outside leader exiting last turn, was floated out some by same rival in deep stretch while bumped and narrowly missed while three deep on the wire. PRINCE BANDINI chased the pace from the inside into backstretch, came out into second turn then two wide and between foes into the lane and went willingly to the wire. HUSBAND'S FOLLY chased three wide around both turns, bumped with outside rival in upper stretch and finished with interest. SPUD SPIVENS settled from between rivals, continued two wide and lacked needed late response. BRASS PLATE reserved from the inside, saved ground to the second turn, angled out and was no late threat. PALIO PRINCE broke in bit but stepped to the front, set pace along the rail into backstretch, lost lead, stalked the leader to second turn then weakened. BABY BULL settled well off the rail and off the pace, raced three then four wide to the stretch, was bumped passing eighth marker and weakened. FREE POURIN prominently placed early from between foes, chased on same two wide path but gave way readily. The stewards conducted an inquiry into the incident nearing the wire and disqualified AQUA FEVER and placed him third for coming out under left hand urging then making contact with and causing TWICE THE APPEAL a chance for a better placing.
