Footnotes

SEREFINA was permitted to settle early, advanced three wide on the turn, rallied through the lane, split the leaders near the wire and tagged ATCHAFALAYA BAY late. ATCHAFALAYA BAY was always forwardly placed, rallied four wide into the lane, took command in mid stretch and just failed to last. HEARDABIRD stalked the pace three wide early, challenged four wide into the lane, ducked in and bumped EBANI at the furlong pole and slackened late. PINK MENACE (MEX) lagged early, advanced inside on the turn, came off the rail in the upper stretch but shifted back inside at the furlong pole and finished steadily. TOPPERS WAY settled early, advanced four wide to the stretch and flattened out. EBANI broke in stride and dueled three wide from the outset, continued on the lead into the stretch, was bumped by HEARDABIRD at the furlong pole and gradually faded. MCKINLEY SKYE was void of any

early speed, moved up from off the rail on the turn but lost his punch in the lane. VALDOURA'S HEAT dueled from the inside to the turn, came off the rail at mid turn but had little left. MUCHACHA DEL RIO showed little. JANLISA rushed up to duel for the lead from between horses and stopped. EASTER CHEER was never a serious factor. NANNY OGG had no speed. The stewards posted the inquiry and for interference to EBANI at the furlong pole they disqualified HEARDABIRD from third and placed her sixth.
