EAGLE SCREAMS settled for a half, bid two wide into the second turn, swung out three wide, rallied when set down for the drive, came in slightly late, bumped with the runnerup who was drifting out then got the nod on the line. HEROICALLY was a pace factor throughout, responded two wide to the stretch, took a short lead to deep stretch then drifted out in deep stretch, bumped the winner but battled gamely to the line. CURLY BOY trailed to the second turn, came two wide then swung out into the stretch and closed with a stout run late. PHOTO SHOPPED had no speed, was behind rivals and in check to the second turn, got forced out five deep to the stretch, rallied to mid stretch but could not make an impact late. CALL ME KELLY was on the pace from the rail for six furlongs, fought bravely to mid stretch then tired. MICHAEL THE MAN took back in the opening stages, settled to the second turn, made a bid four wide to the stretch but flattened in the final furlong. MUSIC APPEAL chased the pace to the second turn, offered his best try three wide to the stretch but lost his punch in the drive. MAGIC OF THE MOON tracked the pace to the second turn, was giving way to the stretch then broke down in mid stretch and was vanned off. The stewards posted the inquiry sign and the rider on HEROICALLY claimed foul against the winner in regards to the bumping incident in deep stretch but the stewards ruled that both horses had a part in the contact and no change was warranted.
