HOOVERGETTHEKEYS broke alertly then took back off the leaders from the rail, remained inside into the second turn, shifted out and split the leaders entering the stretch, bumped with MEDIA MOGUL nearing the furlong pole, was quickly straightened then drew off while being kept to his task. HIGH CASCADE set all of the pace from the inside to the stretch, could not go with the winner but kept to his task and held the place. MEDIA MOGUL (GB) was never too far back from the outside, offered his best bid three wide at the quarter pole, bumped solidly with the winner in the upper stretch and lost his punch afterwards. SIR ALFRED settled early from the inside, remained on the rail and offered a menacing bid on the backstretch but lacked a response in the final three eighths. BANK STREET lacked early speed, raced two wide throughout and failed to rally. HEAVEN'S TREAT was always within striking distance from the outside, got fanned four wide on the second turn and did not respond. MOISUISATOI prompted the pace two wide to the second turn, lugged out sharply at the quarter pole and stopped. The trainer of MEDIA MOGUL lodged an objection against the winner for interference in the upper stretch but after reviewing the films, ruled that the contact was fifty-fifty and allowed the original finish to stand.
