FINAL WONDER was hurried in the early stages but could not keep up and raced mid pack, bid two wide leaving the three eighths, swung four wide into the stretch then closed with a rush late to be along in time. GRACIAS chased the pace to mid turn, raced three wide to the stretch then also closed willingly but was outkicked late. NATURAL PEARL was a pace factor outside rivals to the turn, came three wide to the stretch, dug in gamely late but was bested. CRAZY KIMBER tracked the leaders to the turn, raced two wide to the stretch, angled inside of MISS SMOKE SIGNALS and rallied on the rail late. MISS SMOKE SIGNALS was on the pace from the rail to the stretch, responded to pressure to deep stretch after drifting off the fence in mid stretch but was outfinished. ZAZAMORA was also a pace factor from between rivals to the stretch, responded to deep stretch but was weakening late. SIMPLE TRUTH was outsprinted, raced two wide to the stretch then could not muster the needed response. MYSINCIRCUS chased the leaders to the turn, was fanned four wide to the stretch and lacked a closing response. FLAMING SKY had no speed, got fanned out five wide while trying to rally on the turn and did not threaten.

FAIR TECHNOLOGY broke a bit slow and trailed to the turn, then was three wide to the stretch but not a factor. TANNER'S DIAMOND stalked the leaders in the early stages then saved ground but gave way. GRIEVANCE was five wide after having no speed and showed little.
