DENALI CAT prompted WATCH OUT WORLD from the outset, rallied to that rival two wide on the turn, forged to the front entering the lane, edged clear near the furlong pole then drifted out slightly late but held gamely. HEART OFA CHAMPION was never too far back, rallied three wide into the lane, checked very briefly off the winner inside the sixteenth pole but could make no impact. MARKET GARDEN was bumped at the start and was not asked for early speed, commenced her bid three wide at the three eighths pole, dropped inside for the drive and closed willingly. TALE OF A DREAM broke in and bumped MARKET GARDEN then was settled, raced two wide on the upper turn, lugged out over the heels of MARKET GARDEN nearing the quarter pole but closed with good speed once straightened for the drive. WATCH OUT WORLD set the pace under pressure from the inside to the head of the lane and slackened. VIANSA OSSIDIANA stalked the pace to the quarter pole from the inside then failed to respond. TAVY'S PLAN showed some speed from the rail to the turn, slackened leaving the three eighths and steadied hard near the quarter pole and fell from contention. The rider aboard HEART OFA CHAMPION lodged an unsuccessful claim of foul against the winner for interference in the stretch.
