TROUBLE X TWO set all the pace to the stretch, kicked away to mid stretch and was under steady urging to the line. I DIDN'T CHEAT tracked the winner to the second turn, raced two wide to the stretch then could not make an impact and just saved second. GOOD COMPANY had no speed, settled to the second turn, was fanned four wide to the stretch then was gaining for second. STRETCH HOME pressed the winner for six furlongs while two wide, was outkicked to mid stretch and weakened. MAJESTWAY had no speed and was not a threat. CAST A VISION also had no speed, was forced out four wide to the stretch and did not rally. ALTEEZO settled mid pack to the second turn then was three wide to the stretch and also lacked a response. MONSAJEM MANEGE saved ground to no avail. TIME TO GLOW was fanned five wide to the backstretch, tracked the pace to the second turn but gave way in the stretch. EXCESSIVE PAYNE stalked the winner for five furlongs, stopped on the second turn, was eased in the stretch but walked off.
