NEON QUEEN pulled to the lead shortly after the start, set the pace in hand to the second turn then was ridden out to the wire. CHIC DOMESTIQUE chased the winner while saving ground to the stretch and had a mild bid to be second best. PALACE ROYALE (IRE) had no speed, saved ground to the stretch and closed some through the drive. PLANONCOMETBEBOPIN was allowed to settle, raced outside a rival on the second turn and also made some late progress. GIFTED DAUGHTER chased the pace to the stretch but weakened in the drive. MUSCHI had no speed and did not threaten. COLOR ME SPECIAL was allowed to settle, tried to rally three wide to the stretch but gave way in the drive. FORTY ON LINE (GB) was wide throughout and not a factor.
