Footnotes

BROUGHT TO JUSTICE broke alertly then was taken back off the pace and raced unhurried to the second turn, commenced her bid leaving the five sixteenths, split foes into the stretch, rallied steadily and came through between rivals late to gain command and outfinished VEILIT in the final strides. VEILLIT' lagged early, advanced from the inside on the second turn, lacked room briefly entering the lane, angled outside DEMANDING DIVA once in the lane, split horses late and finished steadily. DARK DOLORES raced unhurried early, was fanned five wide while advancing on the second turn, loomed a bold factor from the extreme outside at the furlong pole but lost her punch. VICKY VALE raced up from the extreme outside on the first turn to engage for the lead, pressed the pace two wide into the stretch and slackened. CATEGORY TEN was not asked for speed to the second turn, was forced to rally six wide into the stretch to lose some of her momentum then closed a mild gap in the late stages. BACARDI BAY set the pace from the inside to the head of the lane and weakened. DEMANDING DIVA was never far back, moved up from the inside into the second turn but had little left once in the stretch. GLORIFIED PRINCESS raced within easy striking distance from the outside to the second turn, offered a brief bid three wide nearing the quarter pole but gave out once in the stretch.
