Footnotes

PLEASURE FAIR broke alertly and dueled outside FRIENDLY HOUSTON to mid turn, disposed of that rival then met a bid from MISS TIBURON, drew clear leaving the furlong pole and extended her advantage driving. MISS TIBURON broke poorly and behind her field, rushed up impressively to reach contention in the opening quarter, challenged the winner from the outside on the turn but could not match strides in the lane. ANDREA'S ANGEL was permitted to settle early, raced four wide to the stretch and lacked the needed response. RUBY BALLETT tracked the leaders from between horses to the stretch and weakened. FRIENDLY HOUSTON dueled for the lead from the rail to mid turn and slackened. MATZO BALL had only brief speed from the inside. KITTYBANGBANG bumped hard with FARE YOU WELL shortly after the break, fell back and did not threaten. MY LAST BAT was fractious in the paddock and post parade, then lacked early speed, saved ground and was never a factor. FARE YOU WELL bumped hard with KITTYBANGBANG after the start and was never a serious threat. TRESOR DU JOUR showed little.
