BOLD PRETENSE contested the pace from off the rail to the stretch, edged away to mid stretch then was kept to task to the wire. **SWISS LAKER GIRL** chased the leaders to the turn, bid two then three wide to the stretch, loomed a threat to mid stretch but flattened in the late stages while never threatened for second. **PANDA BAI** had no speed, raced two wide to the stretch then failed to threaten while improving position. **SISTERMARYELEPHANT** chased the pace from the rail to the stretch then weakened. **ZAREE** had no speed and was outrun. **L A SUPERIOR COURT** flashed speed and dueled inside the winner to the quarter pole but tired in the stretch and stopped. **OUR AUDITOR** went wrong behind, pulled up lame then was walked off.
