Footnotes

DUNBAR had the best speed, set all the pace to the second turn, met a bid from SOUL DE NASKRA to the stretch, outkicked that one to mid stretch and held driving. MINISTER VIVENDI trailed to the second turn, was two wide to the stretch then eased widest in upper stretch but could not impact the winner while drawing clear of the rest. SOUL DE NASKRA pressed the pace to the second turn, bid two wide to challenge for the lead at the five sixteenths, was being outkicked into the stretch, drifted inward, bumped RON'S RANGER at the three sixteenths, recovered but went evenly late. DREWTHETIGER stalked the winner to the second turn, offered a rally three wide to the stretch, was also outkicked in upper stretch and weakened. RON'S RANGER was unhurried to the half, made a bid inside on the second turn, was crowded and bumped off stride by SOUL DE NASKRA nearing the three sixteenths and gave way. Following a steward's inquiry, SOUL DE NASKRA was disqualified and placed last for interference in upper stretch.
