**Footnotes**

DE BRIEF ME brushed with VENOM G at the start and raced unhurried to the turn, remained in hand while following BLACK GULCH into the lane from the inside, shifted inside that rival nearing the furlong pole and offered a quick bid to gain command and edged clear driving. NAUTICAL RULE dueled for the lead from off the rail into the lane, lacked a solid closing punch but held well for the place. BLACK GULCH raced up inside after the break to be well placed, remained inside while rallying into the stretch, drifted out in the upper stretch while taking command then weakened in the final furlong. VENOM G bumped with the winner at the break and raced in reserved to the turn, advanced three wide to the stretch, loomed a bold factor at the furlong pole but lost his punch. DEPUTY PRIZE was void of speed to the stretch, angled widest once in the stretch and closed a gap. JO'S WILD ABANDON pressed the pace from the outset, gained a short lead from the rail at the quarter pole but had little left for the drive. IRISH HARMONY stalked the pace four wide under a snug hold then failed to respond once in the stretch. HAJA BOY dueled three wide for a half mile and stopped.
