KISSN TRISTAN pressed the pace three wide to the second turn, bid three wide to the stretch, dueled to deep stretch then dug in gamely late. QUOTATION was three then four wide to the backstretch, settled to the half, came two wide to the stretch, ran into traffic in upper stretch, checked nearing mid stretch then rallied when clear but was too late. BIG COZZ stalked the pace early then was bumped by GREY ALYCATTA and steadied at the eleven sixteenths, settled to the second turn, swung out four wide to the stretch, rallied to deep stretch then was outfinished. GIANT STEPS set a pressured pace while off the rail to the second turn, remained two wide to the stretch, battled to mid stretch then tired. GREY ALYCATTA was fractious in the gate then was away bit slow, pulled the rider nearing the three quarter pole, ran up heels and was steered inward crowding and bumping BIG COZZ at the eleven sixteenths pole, continued to pull when clear, dueled from the rail on the second turn but stopped after six furlongs. The stewards conducted an inquiry into the incident involving BIG COZZ and GREY ALYCATTA on the backstretch but ruled that although GREY ALYCATTA caused the bumping, BIG COZZ beat GREY ALYCATTA and no change was warranted.
