LAST STING was permitted to settle early but was never far back, advanced three wide to the stretch to challenge for command at the furlong pole, dueled and proved best late. SOUTHFIELD FOG set all of the pace from the inside, met the winner's bid but could not resist late. IRENES JACKPOT stalked the pace from the rail throughout but lacked the needed response. FLIGHT OF A DREAM broke in the air and fell back early, raced unhurried to the second turn, rallied four wide to the stretch then flattened out. EVIE JO lagged early from the inside, came two wide to the stretch and went evenly through the lane. MISS CORINTHIAN tracked the pace from the outside for six furlongs and gave way.
