APPEALING RESUME was outsprinted early, chased the leaders to the turn, rallied when asked but was forced out four then five wide to the stretch, pushed up to duel to mid stretch then edged away under steady handling. DINNR WITH NIKKI C set a pressured pace while off the rail to the stretch, dug in and resisted the winner to inside the furlong grounds, could not keep up late but was game to hold the place. MINER PIC was also outsprinted to the turn, saved ground while rallying to mid stretch, loomed boldly a furlong out but hung in the final sixteenth. RED WHITE AND BREW prompted the pace to the turn, continued to be a factor while three wide to mid stretch but weakened in the final furlong. ESCUINAPA trailed throughout.
