SHAWKLIT SUNDAE emerged from between horses after the break to duel from off the rail, edged clear on the turn then extended her advantage while being kept to her task. TOPPER'S SMILING prompted the winner from the outside throughout but could make no impact. GOOD TIME'N DIXIE settled early, came four wide to the stretch but failed to rally. LOUISIANA LAWYER broke alertly then slipped back, try to rally outside GOOD TIME'N DIXIE but came up empty. HEART'S MUSIC was always outrun.
