Footnotes

BRIAN THE BRAVE was a pace factor from the outset, edged away to the stretch then responded and drew clear to mid stretch and was ridden out to the line. U. C. MERCED TWO was outsprinted to the turn, got fanned four wide to the stretch then could not threaten the winner while the best of the rest. MR GEAR had no speed, saved ground to the stretch, drifted out under left handed whipping in upper stretch and crowded EASTER CANDY then finished evenly to the wire. EASTER CANDY chased the leaders to the turn, bid two wide to the stretch, was crowded and forced to check twice to the three sixteenths then finished evenly. SCOTT'S SPIRIT was hustled but was outsprinted by the winner, pressed that one three wide to the quarter pole then tired in the drive. The stewards conducted an inquiry into the stretch run involving MR GEAR and EASTER CANDY but in a majority decision they did not alter the original result. The majority found that although MR GEAR did come out and take the path of EASTER CANDY, that one was not cost a better placing.
