MY GAL CANDY was well placed while mid pack for a half mile, rallied three wide into the second turn, came two wide to the stretch, pushed to the front a furlong out then held off YER WOMAN (IRE) in the late stages. YER WOMAN (IRE) The latter was unhurried for a half, circled rivals four wide while rallying on the second turn, loomed boldly in mid stretch but was outfinished late. NOISE OF THE CROWD was on the pace two wide to the half, inched away on the second turn, saved ground into the stretch then was collared in mid stretch and weakened. SCREAMING REGAL had no speed, saved ground to the second turn, tried to rally from the two path to the stretch but could not make an impact. BIG TIME SUNSHINE chased the leaders to the second turn, offered a good bid four wide on the second turn, was three wide into the stretch but lost her punch late. GOTNACEUPERSLEEVE stalked the leaders three wide for five furlongs, stopped on the second turn then was eased in the stretch but walked off. THIRTY (ARG) was pushed to the front in the early stages, set a pressured pace for a half mile, also stopped on the second turn then was eased in the stretch and also walked off.
