VINDI MAN settled mid pack for a half mile, bid two then three wide on the second turn, responded once straightened for the drive and dug in determinedly to be along in time. COME ON DEPUTY pressed the pace early, permitted LOVEMEIM�OURS second place on the backstretch, bid two then three wide into the stretch and finished willingly late but missed. AIRPLANE MODE set the pace for six furlongs, edged away under pressure to mid stretch, battled late but was bested. CITY CHAPEL was unhurried for a half, bid two wide on the second turn then was gaining ground belatedly in the drive. ROGUE DANCER settled in the early stages from the rail, shifted out on the backstretch and had to circle rivals four wide on the second turn and lacked the needed late response. FINAL FOOT hopped in the air at the start, trailed to the second turn then saved ground but failed to threaten. LOVEMEIM�OURS stalked the pace early, moved up to take over second on the backstretch, was asked for more inside on the second turn but tired through the stretch. ATOMIC VISTA was allowed to settle for a half, raced three wide on the second turn but stopped in the stretch.
