Footnotes

CASTLE DERMOT was checked leaving the chute when the rider stood up, chased the pace to the turn, raced two wide to the stretch then rallied willingly late and held driving. HIGH INTELLECT stalked the pace to the turn, got fanned four wide to the stretch, rallied when roused but was outkicked by the winner. TACTFUL showed good speed, set the pace from the rail to the stretch, responded to mid stretch but weakened in the late stages. SIX PACK ABS tracked the leaders to the turn, was four wide into the turn then was fanned five wide to the stretch while losing some ground and closed belatedly in the final sixteenth. LOOKN FOR THE LORD attended the pace three wide to the stretch but weakened in the drive. MAIDENS JUSTICE had no speed, was caught four wide to the stretch and also failed to rally. DEFENSIVE MOVE showed speed to the turn, dropped back some while two wide to the stretch then gave out.
