LADIES DIN was permitted to settled in the early going from the inside, shifted off the rail once on the backstretch and advanced gradually to the second turn, responded quickly when called upon to rally four wide and between horses to the stretch, continued to respond once straightened for the drive, headed FIGHTING FALCON at the furlong pole and outdueled that rival to the line. FIGHTING FALCON was unhurried early from just off the rail, rallied three wide and inside the winner at the quarter pole, held a short lead in the upper stretch, was headed by the winner at the furlong pole but dug in willingly and gave way grudgingly. SELF FEEDER (IRE) well placed from the outset, entered the stretch two two wide, tried to get through inside MR. DOUBLEDOWN leaving the furlong pole, steadied then shifted around that rival while losing momentum then came back on too late. ADCAT lagged to the second turn, tried to rally six wide into the stretch but lacked the needed response. MR. DOUBLEDOWN broke alertly and dueled two wide to the stretch and gradually faded. ALERT AND READY well positioned from the rail, remained inside on the second turn but had no response. DEPLOY VENTURE (GB) raced unhurried early, was fanned five wide to the stretch and failed to rally. MONTEMIRO (FR) forwardly placed from the outset, offered an early bid three wide nearing the half mile pole to duel for the lead into the stretch and gave out. ROYAL COURT set the pace from the rail to the second turn and stopped. VOICE OF DESTINY flashed only brief speed from the outside.
