### Footnotes

RENDEZVOUS was three wide to the backstretch, settled to the half, bid three wide into the second turn, was forced to circle rivals five wide into the stretch but finished willingly and was along in time. DYNAMIC HOST was allowed to settle to the half, closed ground inside on the second turn, rallied and stuck a head in front leaving the sixteenth pole but could not hold off the winner. DUNMORE EAST set the pace from off the rail for six furlongs, responded to pressure in the stretch, stayed gamely to deep stretch but was drifting out late. CANDY STORE got fanned four wide to the backstretch, stalked the leaders to the second turn, rallied four wide to the stretch, engaged DUNMORE EAST in mid stretch, battled to deep stretch then was being outfinished and checked nearing the wire. MAYBE YES chased the pace to the second turn, bid three wide to the stretch but lost his punch late. PAUL'S HOPE pressed the pace for a half, offered a run three deep on the second turn but tired after seven furlongs. DANCE CHIEF trailed throughout.
