MICHIGAN BLUFF had no speed and settled well off the pace, rallied three wide on the far turn to reach contention, responded to pressure through the drive and tagged CHIME AFTER CHIME late. CHIME AFTER CHIME set the pace early, pulled clear on the backstretch, responded into the stretch, dug in gamely late but was caught. UNBRIDLED STAR chased the leader while saving ground to the stretch, rallied to loom a factor in upper stretch but lugged inward when passing the temporary rail in deep stretch and gave way. MISTER CRAFTY chased the pace three wide, made a run two wide on the far turn to loom a factor into the stretch but flattened out late. AFFIRMED JUDGEMENT was allowed to settle but lacked the needed late response. JOI'S FLAME stumbled at the start, recovered, had no early speed and did not threaten. ROSE CARNIVAL (GB) was not a factor.
