### Footnotes

MUTINY BAY was fanned four wide on the first turn, stalked the pace to the half, rallied three wide on the second turn, dueled to mid stretch then battled while drifting out and inched away late. SAMMY CHOI attended the pace to the half, dueled two wide to the stretch, dug in gamely to battle the winner to deep stretch but was outfinished late. ALL SLEWS STAR was allowed to settle for a half mile, was asked for more nearing the second turn, got fanned four wide to the stretch then closed ground belatedly in the final furlong. CARNIVAL CANDYMAN had no speed and settle, shifted three wide on the second turn but was outrun through the drive. MO PLEASURE was rank to the backstretch, finally settled leaving the five eighths, raced two wide on the second turn but did not threaten. WHEELS OF FIRE contested the pace for six furlongs, stopped in upper stretch then was eased but walked off.
