YOU'RE MY BOY BLUE settled to the turn, was roused and circled four wide while rallying into the stretch, pushed clear to mid stretch then held driving. RASGADO prompted the pace to the turn, bid three wide to the stretch, was outrun to mid stretch then chased the winner home while second best. FOX IN THE HOUSE trailed to the turn, got fanned four wide to the stretch then failed to mount a serious rally. YOUNIQUE CAT hustled early and set the pace under pressure to the middle of the turn, was collared into the stretch then weakened through the drive. MEDIA MAN pressed the pace two wide to the stretch then gave way. FOREARLTHEPEARL saved ground to no avail.
