Footnotes

ROSIE KYLE raced green in the early stages, dropped inside into the stretch, responded and rallied steadily while easing outside CELESTIAL COUNCIL and collared that rival late to win driving. CELESTIAL COUNCIL dueled from the inside, edged clear at the furlong pole but shortened stride nearing the wire. SLUGGER GIRL stalked the pace from the outset, raced three wide to the stretch and failed to rally. MYSWEETGUARANI lacked good early speed, was four wide early on the turn, gradually dropped nearer the rail nearing the stretch but did not rally. POWER OF TEN was very, very slow into stride but closed some ground steadily. MYSTICAL POWER broke quickest but was quickly caught, dueled two wide to the stretch and stopped.
