### Footnotes

LIT DE BET broke alertly then was permitted to slip back off the leaders, advanced four wide on the turn, gained command inside the furlong pole and won driving. CRAZY THINKING prompted the pace from the three path, gained a short lead in the upper stretch but was outfinished. ELIZABETH A raced up inside to stalk the pace from the rail, eased out for the drive then had to steady hard at the sixteenth pole to get through between LIT DE BET and CRAZY THINKING, shifted out and came on again. KINTLA JOURNEY set the pace from off the rail and weakened. RUNNING RACHIE was well placed just off the leaders, raced two wide on the turn but did not rally. COUNTY WEXFORD was unhurried early, saved ground to the stretch but failed to reach contention. PEEK A BOOP lagged early, was three wide on the turn and did not rally. MY SIRAH SIRAH showed little.
