SYLVIE was well placed to the half, moved up inside rivals to duel for the lead on the second turn, pushed away to mid stretch then edged clear driving. BLUSHING BEAR CAT was allowed to settle for a half, saved ground and closed ground on the second turn then came on late without threatening the winner. HEART'S MUSIC had no speed, was roused three wide on the second turn, angled out in upper stretch and closed well late. STORMY VOW tracked the pace to the second turn, was in the two path then eased to the rail into the stretch to loom a factor to mid stretch but slackened in the late going. DANA SISSTAR settled mid pack to the second turn, was fanned four wide to the stretch but failed to mount the needed response. GLORIA JEANNE also

settled for a half mile, came three wide to the stretch but did not threaten in the drive. HELLO BOLLY prompted the pace from the three path to the second turn, moved up to duel to the stretch but gave way in the lane. STORMY CYRINA had no speed and was not a threat. TILTED ANGEL was hustled to the lead, set the pace for five furlongs then gave out in the stretch. BUNNY AT THE LAKE was fractious in the gate then had no speed and stopped in the stretch. I LOVE CHARLEY bobbed at the start and lost her rider. The stewards conducted an inquiry into the start of the race but failed to alter the results.
