CALLMELAURYN was unhurried to the half, commenced a bid outside rivals into the second turn, was forced to circle five wide into the stretch then responded gamely through a long drive and was up late and drew clear. PENNY ANTE stalked the pace to the half, rallied inside and took over into the second turn, responded and resisted GODS EAR to deep stretch but could not stall the winner. GODS EAR was settled to the half, rallied between horses and three wide on the far turn, was up to duel for the lead to mid stretch then was outfinished. ECLIPSE WINNER had no speed, was asked into the second turn, shifted between horses at the quarter pole then finished evenly late. NEW ROSE (PER) was settled to the far turn, rallied inside to the stretch but came up empty in the drive. JORDYN MACOMA had no speed, came two wide to the stretch then had a mild bid through the lane. DAWN'S ANGEL never far back to the half, made a run inside on the second turn, shifted out of PENNY ANTE into the stretch but gave way through the stretch. SISTER MARY HUGH had no speed, saved ground to the stretch then angled out for room but came up empty. MARTY'S ZEE set a pressured pace to the half then stopped. PLEASURE FAIR attended the pace outside of MARTY'S ZEE and also stopped on the second turn.
