**Footnotes**

SEATTLE DELEGATE had the best speed, set all the pace to the stretch, was collared in mid stretch but dug in determinedly late and held. TAKIN A BREAK broke alertly then was outspinted to the first turn, pressed the pace to the second turn, rallied two wide and drew alongside the winner a furlong out

then could not get by and had to settle for the place. SHADOW JUSTICE stalked the leader to the second turn, rallied three wide to the stretch then finished steadily to the wire. DA NICKY never far back to the half, saved ground to the stretch, was right behind the leaders and under strong urging but could not summon the needed response. HURRICANE DEPUTY was allowed to settle, raced three wide to the stretch then was outfinished to the line. MISTER STANKY was allowed to settle early, advanced three wide on the second turn and was in contention into the stretch but finished evenly in the late stages. HOLD THE ADVANTAGE had no early speed, advanced inside on the second turn but also could not make an impact in the late stages. TRAIL BLAZER saved ground throughout, eased out for the stretch run but was a bit erratic and did not threaten. A NEW LEVEL had no speed, raced two wide to the stretch and also failed to rally. CASEY D pressed the pace to the half, got fanned four wide on the second turn then gave way through the stretch. DR. POOH never far back while well out down the backstretch, was caught in the four path on the second turn and weakened through the lane. RILEYS RAINBOW trailed throughout.
