**Footnotes**

MAIDENS JUSTICE had no early speed, advanced leaving the three eighths, raced two wide to the stretch, was crowded and forced into CONCLUSIVE in upper stretch, bumped twice with that one then dug in gamely and edged away in the late stages. LIGHTNING DIABLO was outsprinted early, raced three wide to the stretch then closed steadily to the line. SEISMOMETER chased the pace to the turn, was fanned four wide while rallying into the stretch, dueled to mid stretch but weakened in the late stages. CONCLUSIVE was hustled early and amongst the leaders then took back nearing the turn, saved ground to the stretch, was crowded by the winner and bumped twice with that one in upper stretch, steadied and lost any chance. PEACE OF ME also had no speed, shifted out for room and was fanned four wide to the stretch then failed to rally through the lane. A K RACER was pushed along early and dueled three wide to the stretch, drifted inward slightly in upper stretch, crowding the winner and CONCLUSIVE then weakened through the final furlong. MATT'S MARAUDER had speed to the middle of the turn then gave out. The stewards conducted an inquiry into the action in upper stretch involving the winner, CONCLUSIVE and A K RACER. They concluded that A K RACER had tightened things up and caused the bumping between the other two and since MAIDENS JUSTICE and CONCLUSIVE had beaten A K RACER no change was called for and the original result was allowed to stand.
