VERY FAIR contested the pace to the turn, edged clear to the stretch then responded in the drive and held. LEGAL SEPARATION tracked the leaders to the turn, was boxed and had to check briefly mid turn, shifted three wide for room, rallied when clear but was outfinished in the final furlong. MINISTERSWILDRIDE was outrun to the turn, raced four wide to the stretch then lacked a closing response. BROTHER JOHN attended the pace outside rivals to the turn, was three wide to the stretch and gave way in the drive. MY TOPPER hesitated in the gate, broke slowly and had no speed and did not threaten. CRYSTAL MTN. BLVD. was never a factor. SUPER SALESMAN was hustled early, flashed speed to mid turn then stopped.
