**Footnotes**

FELLOW ELDERADO had the best speed, set all the pace to the stretch, responded to urging then was drifting out under left handed pressure in the final furlong but held gamely. I'M A HUMMER had no speed, was asked three then four wide on the second turn, floated out five deep into the stretch then was gaining ground steadily and surged late for second. FLY BLUE pressed the winner throughout, came two wide to the stretch, made repeated bids to deep stretch despite being crowded a bit by FELLOW ELDERADO but could not get by and was tagged for second late. SHOW OFF was allowed to settle for a half, came two wide to the stretch then finished steadily to the line. LEGAL VICTORY chased the pace from the rail to the stretch but could not muster the needed response. ABSOLUTE COURAGE stalked the pace to the second turn, offered his best try three wide to the stretch but weakened in the drive. EASY CITY was four wide early, settled to the second turn but gave way after six furlongs.
